About the Conference

The Government of Karnataka is organising "Constitution and National Unity Convention 2024" to commemorate the 75th year since the adoption of the Constitution of India. As a part of this mega event, two days conference titled 'Constitution and National Unity' is scheduled to be organised on 24th and 25th February 2024. Institute for Social and Economic Change (ISEC) is pleased to anchor Theme II focusing on 'Constitution, Welfare and Development' and Theme III centred around the 'Developmental Paradigms in Karnataka' of the conference.

Theme II: Constitution, Welfare and Development

"The Constitution and National Unity" conference aims to discuss the theme of welfare within the constitutional paradigm, taking a critical look at the developmental trajectory and justice mechanisms in the 75 years since India's independence. The theme is spread over five sessions Session A, "Constitutional Promises and India's Development in 75 years" provides a comprehensive examination of job opportunities, income/wealth distribution, reservation policies, and the state of education, addressing both public and private sectors. In Session B, "Fundamental Rights, Directive Principles and Citizenship" discussions will revolve around Ambedkar's perspective, national unity, the concept of a common civil code, state reorganisation, and the principles of cooperative federalism. Meanwhile, Session C, "Social and Economic Justice" explores social inequity, untouchability, intergroup inequality, malnutrition, poverty, and civic amenities like housing, water, and sanitation. Additionally, Session D scrutinises the intricacies of income inequality and delves into the potential of Universal Basic Income. Session E, "Affirmative Action for Backward Classes and Minorities" critically assesses existing policies focusing on education, land, and women. This conference aims to facilitate a profound exploration of India's constitutional foundations, uniting scholars, policymakers, and practitioners for enlightening discussions and formulating pragmatic solutions to propel the nation toward progress and unity.

Theme III: Developmental Paradigms in Karnataka

The conference will also be centred around Karnataka, exploring crucial dimensions of the state's development and unity. In Session A, "Constitutional Directives, Development and Progress in Karnataka" scholars and policymakers will dissect the intricate web of developmental dimensions of constitution a special reference to Karnataka, inequalities in land ownership in Karnataka -- expectations and realities, and constitution and affirmative

actions with reference to employment in the state. In Session B, the focus will shift to the Karnataka SCSP TSP Act, acknowledged as a potential game-changer for economic empowerment. This session will delve into budget allocations, the effectiveness of the Scheduled Caste Sub-Plan (SCSP), and the Tribal Sub-Plan (TSP). Session C will critically analyse the five guarantees of the Government of Karnataka and the concept of Universal Basic Income. The discussions will provide a nuanced understanding of the policies and their implications for ensuring citizens' well-being. Simultaneously, Session D will address the welfare of backward classes and minorities, emphasising the challenges faced by OBCs, minority communities, and women, paving the way for inclusive policy frameworks. Lastly, Session E will shed light on the Footprints of Social Justice in Karnataka, emphasising the role of historical leaders, artists, and social reformers in shaping the state's socio-cultural landscape. The session will also discuss the Dalit and anti-caste movements in Karnataka.
